## State of Childcare in the United States

## KEY FINDINGS

1. The need for childcare is widespread. Two-in-five parents in the United States pay for childcare weekly or more often, and a majority say they would if not for the cost of doing so.
2. Childcare alternatives are not readily available. Most parents who pay for childcare on a regular basis expect it would take them longer than 1 month to find a suitable replacement if their current provider(s) became unavailable.
3. Expiration of federal childcare funding provisions defies public opinion. Nearly two-thirds of adults express concern about the upcoming expiration of pandemic-era funding for childcare providers, and most believe the federal government should be investing more into childcare than it currently does.
4. Championing expansion of childcare options for families is popular with voters. Seventy percent of adults would be more likely to vote for a candidate who supports expanding childcare options for families.

OPINIONS RE: FEDERAL CHILDCARE FUNDING

More than one-third of all adults, including most parents, report they or someone they know have experienced challenges finding affordable/high-quality childcare in recent years. Nearly a third have missed work due to lack of childcare, including almost half of U.S. parents.

Half of parents who regularly pay for childcare expect it would take them longer than $\mathbf{1}$ month to find a suitable childcare alternative if theirs suddenly became unavailable. One-infive estimate 4 months or longer to find a replacement.

## OPINIONS RE: FEDERAL CHILDCARE FUNDING

Most U.S. adults believe the federal government should be investing more in childcare programs - more than 7 x the share who say there should be less investment ( $51 \%$ vs. $7 \%$ ).

## Parents are more likely than others surveyed to say the government should be providing greater support for childcare programs.

More than three-in-five U.S. adults express concern about the upcoming expiration of pandemicera funding for childcare programs, including nearly one-third who are very concerned.
How concerned, if at all, are you about the expiration of federal funding for childcare programs (pre-K, daycare, afterschool programs, etc.) that is expected to take place in September?


Parents, lower-earning ( $<\$ 50 k$ ), and urban-dwelling respondents express greater concern than others re: the federal funding set to expire in September.

Responses predict a broad, positive reaction to candidates who support expanding affordable childcare options for families. Public support is not strengthened by proposing an increase on taxes for billionaires to fund such an expansion.

OPINIONS RE: CHILDCARE FUNDING
Parents, urbanites, younger (<40) adults, and higher-earners tend to express greater likelihood than others to support political candidates who advocate for expanding childcare options.
